### Review of economic news of Uzbekistan

#### **UZBEKISTAN'S GDP GROWS 8.2% IN 1H 2009**

The Cabinet of Ministers of the Republic of Uzbekistan considered the results of the country's socioeconomic development and measures to overcome the consequences of the global economic crisis at its session on 17 July, UzA reported.

The government said the timely anti-crisis measures had not only prevented growth of inflation, fall of production and decrease of the investment activities, but ensured stable and balanced development of the economy.

The growth of GDP in the first half of 2009 made up 8.2%, according to official data. Industrial production increased by 9.1%, consumer goods production by 13.1%, agricultural production by 4.6%, services sector grew by 18.5% and construction works by 32.5%.

The state budget was implemented with a surplus of 0.3% to GDP, inflation levels did not exceed the forecast parameters, and the people's real incomes increased by 25.9%.

The project with estimated cost \$50 mln provides the construction of 30 AGFCAS in all regions of the country with annual productivity of each station – 4 mln cubic meters of natural gas. The period of realization of the project is 4 years.

### MUBAREK GAS PROCESSING PLANT IS BEING MODERNIZED

The national Holding company "Uzekneftegas" will have modernized the Mubarek gas processing plant in 2009-2010. Within the framework of modernization the construction of the seventh line of gas desulfurization consisting of universal blocks of total capacity 6 bln cubic meters per year will be realized. Till the end of the current year the first block of desulfurization will be launched, and in the beginning of 2010 – the rest two will be put into exploitation. The financing of the project will be realized for the own funds of "Uzbekneftegaz".

THE EXTRACTION OF LIQUID HYDROCARBONS DECREASED IN JANUARY – JUNE 2009

The extraction of oil and of gas condensate on the oil and gas enterprises of Uzbekistan decreased 2.3% to 2 416 mln tn in January –June 2009 compared with the same period 2008, according to the state statistic committee.

In particular the oil production decreased by 8,9% to 1207 mln tn. The extraction of the gas condensate increased by 5.2% to 1,209 mln tn. Petrol production constituted 790,9 ths tn (+8,7%), kerosene - 197,7 ths tn (+15,1%), reduced fuel oil - 281,8 ths tn (+6,2%), diesel fuel - 668,9 ths tn (+8,6%), petroleum-bitumen - 106,4 ths tn (2,6% less).

The natural gas extraction decreased by 1.0% to 31,739 bln cubic meters in Uzbekistan in January – June 2009. The production of condensed gas constituted 126,3 ths tn (+4,6%).

#### UZBEKISTAN INCREASED COAL MINING BY 2,1% IN JANUARY – JUNE 2009

Uzbekistan increased coal mining by 2,1% in January –June 2009 compared to the same period 2008 to 1,745 mln tn , according to the state statistic committee.

In particular coal mining on the open pit mines increased by 6,9% to 1668 mln tn, mining from coal producers decreased 1,9 times to 77,4 ths tn.

According to the statistics, brown coal mining amounted 1,709 mln (+ 2,8%), stone coal mining - 35,6 ths tn (24,7% less).

# SJSC "UZBEKENERGO" WILL BUILD TWO COMBINED CYCLE GAS TURBINES ON TALIMARDJAN THERMAL POWER STATION IN 2009-2013

The State Jount Stock company "Uzbekenergo" will build two combined cycle gas turbines on Talimardjan thermal power station in Kashkadarja region for the cost \$800 mln, said the chairman of "Uzbekenergo".

The realization of the project is to be speed up this year according to the presidents decree. Before it was anticipated to begin this project in 2010. At present OJSC "Teploelektroproject" has got down to the development of the preliminary technical and economic assessment of the project.

The volume of the heat energy released to the consumer in January – June of this year decreased by 7.2% to 9,806 mln gcal.

# THE AUTOMOBILE PRODUCTION ON JV GM UZBEKISTAN INCREASED BY 0.2% IN JANUARY - JUNE 2009

The production of automobiles on the JSC JV GM Uzbekistan (Asaka, Andijan region) increased by 0,2% in January – June 2009 compared to the same period 2008 and amounted 90320 units, according to the State Statistic Committee.

In particular, the production volume of Nexia amounted 40533 units (9,8% less), Matiz - 29968 units (7,7% less), Damas - 10465 units (5,3% less), Lacetti - 8097 units (there was no assembly in January - June 2008), Epica - 591 units (30,6% less), Captiva - 666 units (21,4% less).

Total insurance premium amounted 63,3 bln sum (\$1–1487,81 sum.)

In particular the share of inflow on compulsory types of insurance in total volume of insurance payment constituted 38,5% against 7,6% in January – June 2008, the share of inflow on voluntary types of insurance decreased to 61,5% against 92,4%. The representative of the State insurance supervision said, that the volume of insurance payments increased 1,6 times to 8,8 bln sum during 6 months, average loss ratio constituted 13.9%.

#### THE NATIONAL BANK SUMMED UP THE RESULTS OF THE FIRST HALF OF 2009

24.07.09

In the first half year 2009 the number of served clients reached 1.8 million. The volume of the bank's consolidated balance (in equivalent to national currency) by the results of 1H 2009 in absolute sum made up 5.7 trillion soums (including without offsystem turnovers 4.52 trillion soums).

Credit portfolio of the bank made up over 2 trillion soums (in equivalent of national currency).

By the results of 1H 2009, the bank issued credits in foreign currency worth US\$150.5 million, which is 3.5 times more than similar indicator of the previous year, in national currency — more than 353.8 billion soums. Including for support of small business and private enterprises the bank allocated credits in amount of 136.5 billion soums. Also the bank issued micro credits in national currency worth a total of 16.5 billion soums.

#### THE ASSETS OF THE BANK "IPAK YULI" INCREASED BY 48.4%

By the results of the first quarter 2009 the assets of the open joint stock innovation commercial bank "Ipak yuli" reached 296,6 bln sum (\$1-1487,81 sum), what is 48.4% more than the figure of the same period last year.

The credit portfolio of the bank reached 131,4 bln sum, and the equity of the bank increased by 64% by the results of the first quarter of this year and exceeded 28 bln sum. In comparison with the same period last year the profitability of the bank increased by 87%. The structure of the source of income of the bank is characterized by the equal share of commissions and interest income.


